Short Background of the Fund	It is a €40 million credit line to local Participating Financial Institutions (PFIs) to on-lend to Tunisian SMEs operating in value chains for their investment in high-performing green equipment that integrate energy, water, and resource efficiency. Eligible financing amounts • Up to 100% of investment cost subject to decision by the PFI • Loans / leases of up to €300 000 for preapproved equipment from the Green Technology Selector • Loans / leases of up to €1 000 000 for "assisted projects" with technical support from the GVC team • Financing limit per borrower/lessee over the lifetime of the Facility - is €5 000 000.
How to apply?	Either apply directly at a Participating Financial Institution (PFI), listed in "Financial Intermediaries" section, or contact GEFF SME GVC Tunisia to inquire.  • Complete the application form at (Not Available) and submit it to your local financing branch, along with the supporting documents required.  • All technologies listed on the Technology Selector have been technically pre-approved for financing.
